FEES + PAYMENT

Retainer Fee: The retainer fee is due upon acceptance of this proposal and the accompanying contract. An invoice will be uploaded to your Client Dashboard, and receipt of payment will officially commence the project.

Design Fees: As detailed in the approved proposal

Invoices: Invoices are billed monthly. Remaining balances are due upon receipt unless otherwise noted.

Late Payments: Late payments may incur a [x%] monthly fee and may result in a pause in project progress.

Purchases: Client is responsible for all material, product, freight, and delivery costs.

TERMINATION & CANCELLATIONS

Either party may terminate this agreement with written notice. Client will be invoiced for all time and materials up to the termination date. The retainer is non-refundable and will be applied to services rendered to date.

PHOTOGRAPHY & INTELLECTUAL PROPERTY

Nestled Interiors retains all intellectual property rights to any drawings, renderings, design concepts, and documents created throughout the furniture and décor curation process. These materials remain the property of the Designer until all invoices have been paid in full. The Client is granted limited permission to use the final design plans solely for the intended project. Plans, boards, or visuals may not be reproduced, distributed, or shared with third parties without prior written consent from the Designer.

The Designer reserves the right to photograph completed spaces for use in the company's portfolio, website, social media, and marketing materials, unless the Client submits a written request to opt out prior to photography. Any images used for marketing purposes will exclude personal or identifying information unless expressly approved by the Client in writing.

The Designer may also share images of the completed project on social media platforms and tag relevant collaborators such as contractors, realtors, or builders where appropriate. Clients are welcome to share or repost these images, provided that proper credit is given to Nestled Interiors. Collaborative sharing helps showcase the collective effort behind each project while maintaining brand integrity and design authorship.

Nestled Interiors may recommend trusted contractors, trades, and vendors to assist with the implementation of the approved furniture and décor plan; however, all third-party professionals are contracted directly by the Client. This includes obtaining quotes, confirming specifications, coordinating samples, and assisting with scheduling to help ensure a smooth and cohesive project experience.

While the Designer exercises reasonable care in recommending and coordinating with qualified professionals, Nestled Interiors shall not be held liable for:

- Delays, damages, or defects caused by contractors, vendors, or shipping carriers.
- Variations in color, finish, texture, or material due to manufacturer or production differences.
- Project delays resulting from client approvals, supply chain issues, backorders, or other unforeseen circumstances beyond the Designer's control.
